D. Any Qualification / Observation of CA

1	The firm has maintained two separate account for collection one for collection of sales consideration and another pass through account for tax and other charges from customer.
2	The account of firm is operated under standard instruction wherein collection of sales consideration is deposited in one collection account and from that account amount is distributed 70% to RERA collection account and 30% to normal account. Bank takes 1 day to 8 days time to transfer in those accounts. Consequently there can be short deposit into RERA account till the date such transfer is done.
3	Short deposit of Rs. 35700/- is due to the time taken by the bank to auto transer into RERA account. It is however transerred to RERA account on 02.04.2022.
4	It is noticed that Rs. 51000/- receipt of this Project is inadvertently treated as receipt of Phase I and deposited in those accounts. The promoter has infomed that they will rectify the same.
