D. Any Qualification / Observation of CA

1	The firm has maintained two separate account for collection one for collection of sales consideration and another pass through account for tax and other charges from customer.
2	The account of firm is operated under standard instruction wherein collection of sales consideration is deposited in one collection account and from that account amount is distributed 70% to RERA collection account and 30% to normal account. Bank takes 1 day to 8 days time to transfer in those accounts. Consequently there can be short deposit into RERA account till the date such transfer is done.
3	The bank transerred to 70% (RERA) and 30% account after deducting Bank Charges if any . We, therefore, have taken net of such charges as deposit and withdrawal.
