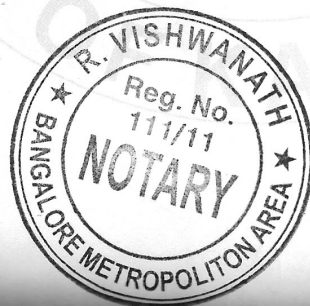
AFFIDAVIT

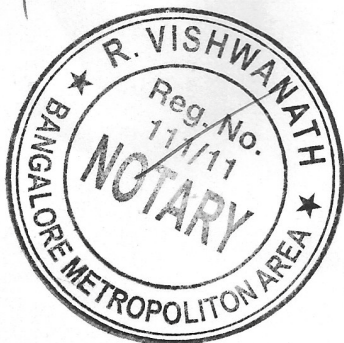
