The procedures summarized below are performed solely to assist you on confirming affairs and prospects of the LLP for the project fund utilization and withdrawal with respect to 47 East - A, project, registered with Maharashtra Real Estate Regulatory Authority (the 'MahaRERA') Registration number P52100024598 as required under provisions of the Real Estate (Regulation and Development) Act, 2016 (the 'RERA') read along with the Real Estate (Regulation and Development) (Registration of Real Estate Projects, Registration of Real Estate Agents, Rates of Interest and Disclosures on Website) Rules, 2017:
