The procedures summarized below are performed solely to assist you on confirming affairs and prospects of the LLP for the project fund utilization and withdrawal with respect to 47 East - A, project, registered with Maharashtra Real Estate Regulatory Authority (the 'MahaRERA') Registration number P52100024598 as required under provisions of the Real Estate (Regulation and Development) Act, 2016 (the 'RERA') read along with the Real Estate (Regulation and Development) (Registration of Real Estate Projects, Registration of Real Estate Agents, Rates of Interest and Disclosures on Website) Rules, 2017 :

1. Traced the total collection received from 01-04-2020 to 31-03-2021 from the customers of the 47 East - A, project by the LLP to the accounting and other relevant records of the LLP. On test check basis, we have traced the collection received from the customer to the bank statement of the Designated Bank Account;
