I, Mr. Dhanraj Baburao Patil promoter of the proposed project THE STRAND duly authorized by the promoter of the proposed of the project do hereby solemnly declare, undertake and state as under:

- 1. That I / promoter have / has a legal title Report to the land on which the development of the project is proposed
- 2. That the project land is free from all encumbrances.
- 3. That the time period within which the project shall be completed by me / promoter from the date of registration of project; Date-30.09.2027

4. (a) For new projects:

That seventy per cent of the amounts realized by me / promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

- (b) For ongoing project on the date of commencement of the Act
- (i) That seventy per cent of the amounts to be realized hereinafter by me / promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 5. That the amount from the separate account shall be withdrawn in accordance with Rule 5.
- 6. That I / that promoter shall get the accounts audited within six months after the end of every financial year by a practicing Chartered Accountant, and shall produce a statement of accounts duly certified and signed by such practicing Chartered Accountant, and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 7. That I/ the promoter shall take all the pending approvals on time, from the competent authorities.
- 8. That I /the promoter shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act and under rule 3 of these rules, within seven days of the said changes occurring.
- 9. That I / the promoter have /has furnished such other documents as have been prescribed by the rules and regulation made under the Act.



10. That I / the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.




