We have been provided with the following documents:

- b) Certificate of Registration for Solitaire Homes Pashan, project having registration Number P52100020848 dated 43600
- c) Bank account statement of separate bank account maintained with IDBI BANK Account Number 0007102000040789 at FC Road branch.
- d) Statement of amount collected from customers of Solitaire Homes Pashan, project As at 31-03-2020.

e) Statement of Cost incurred Solitaire Homes Pashan, Project As at 31-03-2020.

The procedures summarized below are performed solely to assist you on confirming affairs and prospects of the Proprietorship for the project fund utilization and withdrawal with respect to Solitaire Homes Pashan, project, registered with Maharashtra Real Estate Regulatory Authority (the 'MahaRERA') Registration number P52100020848 as required under provisions of the Real Estate (Regulation and Development) Act, 2016 (the 'RERA') read along with the Real Estate (Regulation and Development) (Registration of Real Estate Projects, Registration of Real Estate Agents, Rates of Interest and Disclosures on Website) Rules, 2017:

- 1. We have arithmetically re-Computed the percentage of completion based on the information provided by the management of the Proprietorship and traced the underlying information to the accounting and other relevant records of the Proprietorship;
- 2. Traced the total collection received from 01-04-2019 to 31-03-2020 from the customers of the Solitaire Homes Pashan, project by the Proprietorship to the accounting and other relevant records of the Proprietorship. On test check basis, we have traced the collection received from the customer to the bank statement of the Designated Bank Account;
- 3. Traced the amount Withdrawn from Solitaire Homes Pashan, project of the Proprietorship for The period from 01-04-2019 to 31-03-2020 from the bank statement of the Designated Bank Account to the accounting system;
- 4. Traced the amount of cost incurred on the Solitaire Homes Pashan, project as at 31-03-2020 to the accounting and other relevant records of the Proprietorship;
- 5. Arithmetically re-computed the amount eligible to be withdrawn from the designated bank account for by multiplying the cost incurred till 31-03-2020 with the percentage of completion till 31-03-2020;

- (i) The percentage of completion as mentioned in the Statement is appropriate;
