1. Material Testing :-

i. Cement-

ii. **Coarse aggregate –**

It has been tested, for deleterious materials, clay lumps, crushing value, impact value as per IS code 383:2016 or as per other relevant IS/BS/NBC code or as per industry standards and its results are within the permissible limits.

iii. **Bricks/ blocks –**

They have been tested for water absorption, crushing strength etc. as per IS code 2185: 2005 or as per other relevant IS/BS/NBC code or as per industry standards and its results are within permissible limits.

iv. **Concrete/ Ready-mix Concrete-**

It has been tested for compressive strength for various periods as per IS 456:2000 and IS 1199 or as per other relevant IS/BS/NBC codes, as per industry standards and its results are within permissible limits.

v. **Steel for concrete-**
