




I Mr. Aditya Vilas Javdekar, Age- 44 Years, Occupation- Business, Authorised signatory and Partner of M/s. That the Promoter shall get the accounts audited within six months after the end of every financial year by a practicing chartered accountant, and shall produce a statement of accounts duly certified and signed by practicing chartered accountant, and it shall be verified during audit that amounts collected for a particular Project have been utilised for the Project and the withdrawal has been in compliance with the proportion to the percentage of completion of the Project.

- 8. That the Promoters shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section (2) of Section 4 of the Act and under rule 3 of these rules within seven days of the changes occurring.
- That the Promoters / Promoter have furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- 10. That the Promoters shall not discriminate against any allottee at the time of allotment of any apartment.


