I , Pravin Nigde , have undertaken assignment of certifying Estimated Cost of **SAI AURA, survey no. 103/2B(P), Pimple Soudagar, Tal Haveli, Pune 411027** for having MAHARERA Registration No.( NEW REGISTRATION) being developed by **WJV LANDMARKS LLP**

We have estimated the cost of Civil, MEP and allied works required for completion of the apartments and proportionate completion of internal & external works of the project as per specifications mentioned in agreement of sale. Our estimated cost calculations are based on the drawings/ plans made available to us for the project under reference by the Developer/ Consultants. The Schedule of items and quantity required for the entire work as calculated by Mr. Pravin Nigde , Quantity Surveyor\* appointed by Developer/ Engineer, the assumption of the cost of material, labour and other inputs made by developer, and the site inspection carried out by us to ascertain/ confirm the above analysis given to us.

We estimate Total Estimated Cost of completion of the aforesaid project under reference at Rs. 40,45,27,920/- (Total of Table A & B) at the time of Registration. The estimated Total Cost of project is with reference to the Civil, MEP, and Allied works required for completion of the apartments and proportionate completion of internal & external works, as per specifications mentioned in agreement of sale and for the purpose of obtaining occupation certificate/ completion certificate for the Building(s)/ Wing(s) / Layout/ Plotted Development from the PCMC being the Planning Authority under whose jurisdiction the aforesaid project is being implemented.

The Estimated Cost incurred till date is calculated at Rs 83,15,000./-(Total of Table A & B). The amount of Estimated Cost incurred is calculated on the basis of input materials/ services used and unit cost of these items.

The Balance cost of completion of the Civil, MEP and Allied works for completion of the apartments and proportionate completion of internal & external works, as per specifications mentioned in agreement of sale, of the project is estimated at Rs. 39,62,12,920/-(Total of Table A & B).

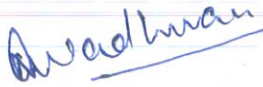
