- 1. At Point no. 3(i) of Form 5, we have relied on the architect's certificate for percentage completion of the project till 31-03-2020.
- 2. At Point no. 3(ii) Form 5
  - a. **Amount collected during the period** means amount collected from flat holders from 01-04-2019 to 31-03-2020 i.e. 100% amount received from flat holders before splitting in 70:30 ratio net off GST.
  - b. Amount collected till date is amount received from flat holders in designated account i.e. Rs. 18,15,000/- which includes amount received in Current year i.e. in FY 2019-2020.
- 3. At Point no. 3(iii) Form 5
