1. Mr. Ajay Bipinchandra Jhaveri having their address at B-201, Riviresa Apartments, Baner Road, Baner, Pune -411045, have approached us for issue of Certificate in Form No. 5 prescribed under RERA Regulations in respect of constructed area to be received and their further sale by him and is registered as "Promoter" (Land Owner/ investor) of the project called "Broadway-Brooklyn, Manhattan & EWS", at Pune, bearing MAHA RERA registration no: P52100016356 described in (2) below.

Mr. Ajay Bipinchandra Jhaveri is the owner and well entitled to plot of land at survey no.185, of Wakad-Thergaon Road, Opp. Pink City, Wakad, Pune 411057 admeasuring 42,800 Sq. Mtrs. Mr. Ajay Bipinchandra Jhaveri entered in to Deed of Confirmation dated 24.06.2008 and Agreement of Assignment of Development Rights dated 09.07.2007 with Innovative Construction Corporation, a registered partnership firm (referred to as "ICC"). By virtue of these two documents, Mr. Ajay Jhaveri is entitled to get constructed area of 24,000 Sq. Ft. free of cost from ICC. Thereafter ICC with the consent from Mr. Ajay Jhaveri, entered into Development Agreement dated 29.02.2016 with Lavim Developers Pvt. Ltd., Pune for the part of the land admeasuring about 29,977 Sq. Mtr. and FSI pertaining to the Road widening and internal road for development As per the said agreement, Lavim Developers are to construct 1720.00 sq.mtr. of carpet area (which is equivalent to 18,500 sq.ft. of carpet area and 24,000 sq.ft. of built-up area) and handover to Mr. Ajay Jhaveri and cost of construction of this area shall be payable by Innovative Construction Corporation to Lavim Developers Pvt. Ltd as giving this area to Mr. Ajay Jhaveri is the obligation of Innovative Construction Corporation as per the agreements of the years 2007 and 2008.

- The said Lavim Developers Pvt. Ltd. has registered the project called "Broadway-Brooklyn, Manhattan & EWS" under RERA Registration Number P52100016356.
 Mr. Ajay Jhaveri is registered as Promoter ("Land Owner/ investor" in the said registration.
- 3. Form 5 is prepared to include cost of land, stamp duty, registration charges and other expenses that Mr. Ajay Jhaveri has incurred to purchase the project land.
