Traced the total collection received from 01-04-2019 to 31-03-2020 from the customers of the Megapolis Serenity A8 to A12, B2 and Conv Shop B, project by the Company to the accounting and other relevant records of the Company. On test check basis, we have traced the collection received from the customer to the bank statement of the Designated Bank Account;
- 3. Traced the amount Withdrawn from Megapolis Serenity A8 to A12, B2 and Conv Shop B, project of the Company for The period from 01-04-2019 to 31-03-2020 from the bank statement of the Designated Bank Account to the accounting system;
- 4. Traced the amount of cost incurred on the Megapolis Serenity A8 to A12, B2 and Conv Shop B, project as at 31-03-2020 to the accounting and other relevant records of the Company;
- Arithmetically re-computed the amount eligible to be withdrawn from the designated bank account for by multiplying the cost incurred till 31-03-2020 with the percentage of completion till 31-03-2020;
