1. Material Testing:-

I/We, have applied following mandatory checks on the basic materials, used in the construction.



i. **Cement-**

It has been tested for its fineness, soundness, setting time, compressive strength etc. as per IS code 3535:1986 or as per other relevant IS/BS/NBC code or as per industry standards and its results are within permissible limits.

ii. **Coarse aggregate –**

It has been tested, for deleterious materials, clay lumps, crushing value, impact value as per IS 2430:1986 or as per other relevant IS/BS/NBC code or as per industry standards and its results are within permissible limits.

iii. **Bricks/blocks –**
