Our estimated cost calculations are based on the Drawings/plans made available to us for the project under reference by the Developer and Consultants and the Schedule of items and quantity for the entire work as calculated by Shri Rajan N Kale quantity Surveyor appointed by Developer, and the assumption of the cost of material, labour and other inputs made by developer, and the site inspection carried out by us.
- **3.** I Estimate Total Estimated Cost of completion of the building of the aforesaid project under reference as Rs.296,35,00,000/- (Rupees Two Hundred Ninety-Six Crores Thirty-Five Lakh only). The estimated Total Cost of project is with reference to the Civil, MEP, Contingencies, Site Staff expenses, other amenities, and allied works
