I, Rohit Krishna Gorule, have undertaken the assignment of certifying Estimated Cost of the building “JP North Euphoria” of the RERA Real Estate Project “JP North Euphoria” [MahaRERA Registration Number - P51700016290], admeasuring approximately **2,861.33 sq. mts.**, situated on the Plot bearing Survey Hissa No.117/1 pt., 117/5 pt., 117/6 pt., 118/2 pt., 118/3 pt. at Village - Ghodbunder, District and Taluka - Thane, PIN - 401107 and being developed by “M/s JP Infra Realty Private Limited.”

1. Following technical professionals are appointed by the Promoter :-

 - ii. **Shri Umesh Joshi** (M/s.- J+W Structural Consultants LLP) as Structural Consultant
 - iii. **Shri Sayed Naziruddin** (M/s. MEP Consulting Engineers) as MEP Consultant
 - iv. **Shri Vijay Joshi** as Site Supervisor
 - v. **Rohit Krishna Gorule** as Engineer / QS for RERA Certification.
2. I have estimated the cost of the completion to obtain Occupation Certificate, of the Civil, MEP and Allied works, of the building “JP North Euphoria” of the project. The estimated cost calculations are based on the Drawings / plans made available to me

for the project under reference by the Developer and Consultants and the Schedule of items and quantity for the entire work as calculated by myself, the Quantity Surveyor appointed by the Developer, and the assumption of the cost of material, labour and other inputs made by the developer, and the site inspection carried out by me.

3. I estimate the Total Estimated Cost of completion of "JP North Euphoria" of the aforesaid project under reference as **Rs.108,62,73,559 /- (One Hundred Eight Crore Sixty-Two Lakhs Seventy-Three Thousand Five Hundred Fifty-Nine only)** [Total of Table A (1) and B (1)]. The estimated Total Cost of project is with reference to the Civil, MEP and allied works required to be completed for the purpose of obtaining occupation certificate for "JP North Euphoria" from the MBMC, being the Planning Authority under whose jurisdiction the aforesaid project is being implemented.
4. The Estimated Cost Incurred till **30.06.2021** is calculated at **Rs. 54,49,44,294/- (Rupees Fifty-Four Crores Forty-Nine Lakhs Forty-Four Thousand Two Hundred Ninety-Four Only)** [Total of Table A (2) and B (2)]. The amount of Estimated Cost Incurred is calculated on the base of amount of Total Estimated Cost.
5. The Balance cost of Completion of the Civil, MEP and Allied works of "JP North Euphoria" of the subject project to obtain Occupation Certificate from MBMC (Planning Authority) is estimated at **Rs. 54,13,29,265 /- (Rupees Fifty-Four Crores Thirteen Lakhs Twenty-Nine Thousand Two Hundred Sixty-Five only)** [Total of Table A (4) and B (4)].
6. I certify that the Cost of the Civil, MEP and allied work for the aforesaid Project as completed on the date of this certificate is as given in Table A and B below:

In case of independent quantity surveyor being appointed by Developer, the name has to be mentioned at the place marked (*) and in case quantity are being calculated by office of Engineer, the name of the person in the office of Engineer, who is responsible for the quantity calculated should be mentioned at the place marked (*).
- b. The estimated cost includes all labour, material, equipment and machinery required to carry out entire work.
- c. As this is an estimated cost, any deviation in quantity required for development of the Real estate Project will result in amendment of the cost incurred/to be incurred.
