I Cyrus Pithawalla have under taken assignment of certifying Estimated Cost for the subject Real Estate Project proposed to be registered under MahaRERA, being (EAGLERIDGE-A), situated on plot bearing C.N. No./CTS No./Survey No./Final Plot No. 120/1A, 120/1C, 123/12D of Division Konkan, Village Kavesar, Taluka Thane, District Thane PIN 400607, BUA admeasuring 8116.74 sq.mtrs. area being developed by M/s.Roma Builders Pvt. Ltd.

1. Following technical professionals are appointed by owner/promoter :-

- (i) Ms. Sharmishtha Mukerjee Shinde as Liasoning Architect.
- (ii) M/s. Mahimtura Consultant Pvt. Ltd. as Structural Consultant.
- (iii) M/s. Clancy Golbal Consulting Engineers as MEP Consultant.
- (iv) Shri. Pradeep Gaikwad as Quantity Surveyor.

2. We have estimated the cost of the completion to obtain occupation certificate / completion certificate, of the Civil, MEP and Allied Works, of the building of the project. Our estimated cost calculations are based on the drawings/plans made available to us for the project under reference by the Developer and Consultants and the schedule of items and quantity for the entire work as calculated by Shri. Pradeep Gaikwad, Quantity Surveyor appointed by Developer, and the assumption of the cost of material, labour and other inputs made by developer, and the site inspection carried out by us.

3. We estimate total estimated cost of completion of the building of the aforesaid project under reference as Rs.59,84,70,819/- (Total of Table A and B). The estimated total cost of the project is with reference to the Civil, MEP and allied works required to be completed for the purpose of obtaining occupation certificate/completion certificate for the buildings from the Thane Municipal Corporation being the Planning Authority under whose jurisdiction the aforesaid project is being implemented.
4. The estimated cost incurred till date is calculated at Rs.5,05,45,614/- (Total of Table A and B). The amount of estimated cost incurred is calculated on the base of amount of total estimated cost.
5. The balance cost of completion of the Civil, MEP and allied works of the buildings of the subject project to obtain occupation certificate/completion certificate from Thane Municipal Corporation is estimated at Rs.54,79,25,205/- (Total of Table A and B).
6. I certify that the cost of the Civil, MEP and allied works for the aforesaid project as completed on the date of this certificate is as given in Table A and B below :-

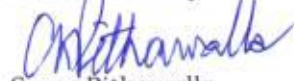
