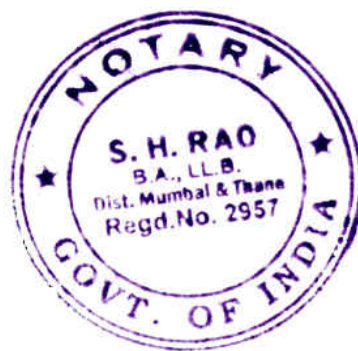

1. That the Promoter, i.e. Kapstone Constructions Pvt. Ltd., has a legal Title Report to the land lying and situate at on the Residential Sub Plot - 7 known as Aurelia, 1st Phase of the project, situated on on the plot bearing Survey No. 51/6(pt), 51/7(pt), 51/8(pt), 51/9(pt) of Village Majiwade, Taluka & District - Thane, Pin 400 602 ("the said Land") on which the development of the project **Rustomjee Aurelia - "1"** ("the Real Estate Project") is proposed.

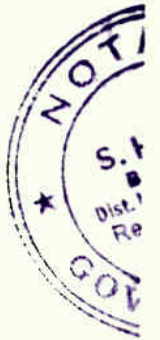
7. That the Promoter shall take all the pending approvals on time, from the competent authorities.
