1. I say that the promoter i.e. M/s Shankheshwar Kretars is entitled to construct the building on the plot of land bearing s.no 6/2 and 73/5/2/1* aggregately admeasuring area 10448 sq.mtr. at village Tiwala, Taluka Kalyan Dist. Thane 421301 (herein after referred said land). I enclosed the authenticated copy of the title certificate of Adv. Sadasiv Suresh Patwardhan dated 09-12-2016 along with the copies of the agreements between such owners and promoter mentioned in title report for development of real estate project herewith

2. I say that we are constructing a project namely "Shankheshwar Crystal Phase 1" on the said land. We intend to develop 8 building namely Bld.no. 1 to Bld.no. 8 and club house, of which Bld.no. 6, is to be constructed for MHADA and Bld.no. 7 and Bld.no. 8, is to be constructed utilizing TDR and premium as propose future expansion on the said land out of which we hereby apply for grant of registration of real estate project for 3 buildings namely Bld.no. 3, Bld. No.4 and Bld.no. 5 and club house (hereinafter referred as Shankheshwar Crystal Phase 1) on the said land .

2. I say that the project land is free from all encumbrances.

3. I say that the time period within which the project shall be completed by the promoter By 31st December 2018
