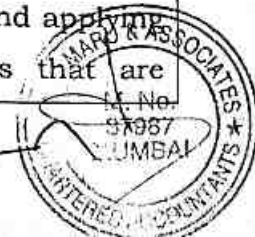

7	This report is issued in the accordance with the terms of our engagement Letter dated 21.01.2023.

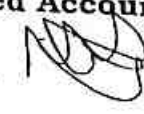
