3. We estimate Total Estimated Cost of completion of the building(s) of the aforesaid project under reference as **Rs. 61,08,29,328/-** (Total of Table A & B). The estimated Total Cost of project is with reference to the Civil, MEP, and allied works required to be completed for the purpose of obtaining occupation certificate / completion certificate for the building(s) from the **Navi Mumbai Municipal Corporation** being the Planning Authority under whose jurisdiction the aforesaid project is being implemented.
