

## **AFFIDAVIT CUM DECLARATION**

I, **Devendra Arvind Awati**, promoter of the proposed project /duly authorized by the promoters of the proposed project do hereby solemnly declare, undertake and state as under:

1. That I/promoter has a legal title Report to the land on which the development of the project is proposed

- That details of encumbrances including details of any rights, title, interest or name of any party in or over such land, along with details as under...

- 3. That the time within which the project shall be completed by me promoter is, 30/07/2021.

(That seventy per cent of the amounts to be realized hereinafter by me promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 5. That the amounts from the separate account shall be withdrawn in accordance with Rule 5 of Maharashtra Real Estate (Regulation and Development) (Registration of Real Estate Projects, Registration of Real Estate Agents, Rates of Interest and Disclosures on Website) Rules, 2016.
- 6. That I / promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a project have been utilised for the project and the withdrawal has followed the proportion to the percentage of completion of the project.
- 7. That I / promoter shall take all the pending approvals on time, from the competent authorities.

That I/ the promoter shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act and under rule 3 of these rules, within seven days of the said changes occurring.
