


- 8. That the promoter shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act andunder rule 3 of these rules, within seven days of the said changes occurring.
- 9. That the promoter have / has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
