2. That the project land is free from all encumbrances.

3. That the time period within which the Entire project shall be completed by me/promoter within 104 months from 01/09/2018, the date of registration of project i.e. by 30/04/2027; The Wingwise completion of the project will be as follows:

Kukreja Classic A Wing - Completion date: 31/08/2022 Kukreja Classic B Wing- Completion date: 31/10/2023 Kukreja Classic C Wing- Completion date: 31/12/2024 Kukreja Classic D Wing- Completion date: 28/02/2026

Kukreja Classic - Amenities and Shops - Completion date: 30/04/2027

- 4. (i) That seventy per cent of the amounts to be realised hereinafter by me/promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 5. That the amounts from the separate account shall be withdrawn in accordance with Rule 5
- 6. That I / the promoter shall get the accounts audited within six months after the end of every financial year by a practicing Chartered Accountant, and shall produce a statement of accounts duly certified and signed by such practicing Chartered Accountant, and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

- 10. That I/the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
