Maheshwari Age: - 37 Years, Occu: - Business, promoter of the proposed project / duly authorized by the Copromoter of the proposed project do hereby solemnly declare, undertake and state as under:

- 1. That Majestique Housing LLP have /has a legal title to develop the land area admeasuring 9650 Sq. mtrs. out of the land bearing Gat no. 569, Wagholi, Taluka Haveli, District Pune totally admeasuring about 8 H. 33 Ares and the area admeasuring 9650 Sq. mtrs which is referred to as the PLOT B situated at Wagholi, Taluka Haveli, District Pune herein after referred to as the "said land" on which the development of the proposed project known as "Manhattan" is to be carried out.
- 2. We have a legal Title to the land on which the development of the project is proposed and Adv. Rameshkumar B. Nage has issued a legal Title Report to the land on which the development of the project is to be carried out.
- 3. That encumbrances Letter is attached for the said land.
- 4. That, we say that the present building/s under the project shall be completed by us on or before 31st December 2019 from the date of registration of project;

OR



ii) We say that entire of the amounts to be realized hereinafter by us/promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose, since the estimated receivable of the project is less than the estimated cost of completion of the project.

accordance with Rule 5 by us.

We say that we shall get the accounts audited within six months after the end

of revery financial year by a Chartered accountant and shall produce a

statement of accounts duly certified and signed by such chartered accountant

and it shall be verified during the audit that the amounts collected for a

particular project have been utilized for the project and the withdrawal has

been in compliance with the proportion to the percentage of completion of

project.

- 8. We say that we/promoter shall take all pending approvals on time, from the competent authorities.
- 9. We say that we/Promoter shall inform the Authority regarding all the changes that have occurred in the information furnished under sub section (s) of section 4 of the Act and under rule 3 of these rules, within seven days of the said changes occurring.
- 10. We say that we/Promoter have/has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- 11. We say that we/ Promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building as the case may be.
