- 2. That the project land is free from all encumbrances.
- 3. That the promoter shall complete the project on or before 31/10/2018.
- 4. That seventy percent of the amounts realized by promoter by promoter for the real estate project form the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 5. That the amounts from the separate account shall be withdrawn in accordance with Rule 5
- 6.
