 That the time period within which the entire project shall be completed by Develoer from the date of registration of project is estimated to be 31/12/2025 mention from date hereof.

4. For ongoing project on the date of commencement of the Act.

That seventy per cent of the amounts to be realized hereinafter by Deveoper for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

- 5. That the amounts from the separate account shall be withdrawn in accordance with Rule 5.
- 6. That the Developer shall get the accounts audited within six months after the end of every financial year by a practicing Chartered Accountant, and shall produce a statement of accounts duly certified and signed by such practicing Chartered Accountant, and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 7. That the Developer shall apply for and endeavor to take all the





pending approvals on time, from the competent authorities.

8. That the Developer shall inform the Authority regarding if any changes that have occur in the information furnished under sub-section (2) of section 4 of the Act and under rule 3 of these rules, within seven working days of the said changes occurring.

That the Developer has furnished such other documents as have been prescribed by the rules and regulations made under the Act.

10. That the Developer shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case maybe.
