Our estimated cost calculations are based on the Drawings/plans made available to us for the project under reference by the Developer and Consultants and the Schedule of items and quantity for the entire work as calculated by Ms Prajakta Gogawale ,quantity Surveyor appointed by Developer/Engineer, and the assumption of the cost of material, labour and other inputs made by developer, and the site inspection carried out byus.

The Estimate is done for 4 parking floors + 15 floors .We estimate Total Estimated Cost of completion of the building(s) of the aforesaid project under reference as Rs. 77.00 Cr (Total of Table A and B).
