- 2. That the proposed project is part of an larger layout proposed to be developed on C.T.S. No. 250 (C) (hereinafter referred to as "the said larger property"). The project is having a plot area of 198.73 sq.mtr. approx of C.T.S. No. 250 (C)(pt)(hereinafter referred to as "the said project").
- That the said larger property also comprises of the other buildings of the layout, of which some are completed and some are proposed.
- 4. That the said project is not encumbered.
- 5. That the time period within which the project shall be completed by me is as per the details to be mentioned by me in the registration of the said project (i.e. 31.12.2030) with the MAHArera.
- 6. - 11. That I shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act and under rule 3 of these rules, within seven days of the said changes occurring.
- 12. That I have furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- 13. That I shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
