AFFIDAVIT CUM DECLERATION

We, **Malpani Properties**, having registered office at 802, City Square, CTS No. 1723, Shivajinagar, Pune - 411005, are promoters of the proposed project "**GREEN PARK PLOT 1**" located at Fursungi, District – Pune, do hereby solemnly declare, undertake and state –

- 1. That we have a legal title to the land on which the development of the project is proposed.
- 2. That the said land is free from all encumbrances.

That we shall get the accounts audited within six months after the end of every financial year by a practicing chartered accountant, and shall produce a statement of accounts duly certified and signed by practicing chartered accountant, and it shall be verified during audit that amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion of the percentage of completion of the Project.
- 8. That we shall take all the pending approvals on time, from the competent authorities.
- 9. That we shall inform the authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act and under rule 3 of these rules within 7 days of the changes occurring.

10. That we have furnished such other documents as have been prescribed by the rules and regulations made under the Act.
