1. Following technical professionals are appointed by the Promoter :-

 - ii. **Shri Umesh Joshi** (M/s.- J+W Structural Consultants LLP) as Structural Consultant
 - iii. **Shri Sayed Naziruddin** (M/s. MEP Consulting Engineers) as MEP Consultant
 - iv. **Shri Siddique Modak** as Site Supervisor
 - v. **Rohit Krishna Gorule** as Engineer / QS for RERA Certification.
2. I have estimated the cost of the completion to obtain Occupation Certificate, of the Civil, MEP and Allied works, of the building "**NORTH - BARCELONA**" of the project. The estimated cost calculations are based on the Drawings / plans made

available to me for the project under reference by the Developer and Consultants and the Schedule of items and quantity for the entire work as calculated by myself, the Quantity Surveyor appointed by the Developer, and the assumption of the cost of material, labour and other inputs made by the developer, and the site inspection carried out by me.

3. I estimate the Total Estimated Cost of completion of “NORTH - BARCELONA” of the aforesaid project under reference as **Rs.143,94,58,695 /- (Rupees One Hundred Forty-Three Crore Ninety-Four Lacs Fifty-Eight Thousand Six Hundred Ninety-Five only)** [Total of Table A (1) and B (1)]. The estimated Total Cost of project is with reference to the Civil, MEP and allied works required to be completed for the purpose of obtaining occupation certificate for “NORTH - BARCELONA” from the MBMC, being the Planning Authority under whose jurisdiction the aforesaid project is being implemented.
4. The Estimated Cost Incurred till 30.06.2021 is calculated at **Rs. 45,60,46,170/- (Rs. Forty-Five Crores Sixty Lakhs Forty-Six Thousand One Hundred Seventy Only)** [Total of Table A (2) and B (2)]. The amount of Estimated Cost Incurred is calculated on the base of amount of Total Estimated Cost.
5. The Balance cost of Completion of the Civil, MEP and Allied works of “NORTH - BARCELONA” of the subject project to obtain Occupation Certificate from MBMC (Planning Authority) is estimated at **Rs. 98,34,12,525 /- (Rupees Ninety-Eight Crores Thirty-Four Lakhs Twelve Thousand Five Hundred Twenty-Five only)** [Total of Table A (4) and B (4)].
6. I certify that the Cost of the Civil, MEP and allied work for the aforesaid Project as completed on the date of this certificate is as given in Table A and B below:
