Sub: Fire safety & protection, opinion for a proposed high-rise building / Low-Rise Building - High Rise Building

Sir,

This is to intimate that, the plans submitted for, High Rise Building, have all the required line drawings and write-up are as per the requirement of fire prevention and protection.

All norms as per the NBC-2016 part-IV fire and life safety guidelines / Gujarat State Fire Prevention & life safety measures Act - Rules / GDCR (2021) & CBD by AUDA / special instructions given by fire officer in charge or Chief Fire Officer have to be followed as far as the construction and Fire Prevention and Protection system, are to be followed as below.

Staircase:

1.5 meters for 9 to 25 meters building heights.

2.00 meters for 25 meters to above building heights, clear in width.

The staircase and lift shafts shall not go to the basement but if they go they have to be protected by 2 hours fire resistant construction including the doors.

A motorable road with 45 ton load bearing capacity and minimum as metion in table; is required around the building without struction to a clear motorable passage for fire/rescue vehicles.

Any transformer to be installed shall be away from the building & leaving open Space required around the building and below building height wise open space required around the building.

Margin for different types of building;

1) 8 to 25 Meters building - 3 meters

Plot area more than 750 sq. mt. : 4 Meters

2) Up to 45 Meters building: 6 Meters

3) Up to 70 Meters building: 8 Meters

The gate (entry) to the premises shall be minimum 6 meters or more if required, in width, entry gate to be provided on both sides.

The Fire Protection system shall be as mentioned in the approved plans.

- 1. All basements parking and HPP shall be fully sprinklered.
- 2. All lower basements should have positive pressure ventilation.

3. Electric Cable Shaft should have fire resistant doors.

Dear Sir,

This has reference to your application along with Form-I, Form-1 A dated 11/03/2022, seeking Environmental Clearance under Environment Impact Assessment Notification, 2006. The project was scheduled for hearing in the SEAC meeting held on 05/04/2022.

The proposal is for Environmental Clearance for the Building Construction Project "Kala Samartheshwar" at F.P. No: 723 + 726, T.P.S. No: 3, Ellisbridge, Chhadawad, Ahmedabad proposed by M/s. Kala Infrastructure. This is a proposed building construction project having plot area of 5,742.82 m² and the proposed FSI area of the project is 17,655.5 m² with proposed built up area of 26,906.96 m². As the built up area is >20,000 m² and <1,50,000 m², it falls in the category 8(a) of the Schedule of EIA Notification, 2006.

The project will comprise of 03 numbers of buildings. No. of Blocks: 03. Scope of buildings/blocks are: Block A+B+C: 1 Basement + Ground Floor (HP) + 1st to 10th Floor and No.& size of Residential Units are: 100 Flats.

The project activity is covered in 8(a) and falls in Category 'B'. Since the proposed project is in item no.8 of the EIA notification, 2006, it does not need Public Consultation as per Para 7(i) III. Stage (3) (d) - Public Consultation of EIA Notification, 2006.

The SEAC Gujarat had recommended the project vide their letter dated 09/05/2022 to grant Environmental Clearance to the SEIAA, Gujarat based on the decision taken during SEAC meeting held on 05/04/2022. The proposal was considered by SEIAA, Gujarat in its meeting held on 16/06/2022 at Gandhinagar. After careful consideration, the SEIAA hereby accords Environmental Clearance to above project under the provisions of EIA Notification dated 14th September, 2006 subject to the compliance of the following conditions.

A. PROJECT SPECIFIC CONDITIONS:

- 1. The original copy of Environmental Clearance granted vide No. SEIAA/GUJ/EC/8(a)/1714/2019 dated 05/12/2019 shall be surrender to the SEIAA within seven days.
- 2. PP Shall not exceed the limit of total built-up area given in the EIA Notification as per the rules of SEIAA.

A.1 CONSTRUCTION PHASE:

A.1.1 WATER:

- 3. Fresh water requirement during the construction phase shall not exceed 25 KLD and it shall be met through tankers. No ground water shall be tapped during the construction phase.
- 4. Sewage generated during the construction phase shall be disposed off through Soak Pit.
- Explore possibilities of provision of mobile toilets in construction phase.

Rules / Gujarat Fire Prevention and Life Safety Measures Act, 2016.

The project proponent shall obtain registration of the establishment under the Building and other Construction Workers' (Regulation of Employment & Conditions of Service) Act 1996 and shall comply with the provisions of the Act for the safety, health and welfare of construction workers.

8. The project proponent shall obtain registration of the safety workers.

- 9. Total water requirement during the operation phase shall not exceed 112.8 KLD, out of which fresh water requirement of 73.5 KLD shall be met through AMC and the remaining 39.3 KLD of water requirement shall be met through treated sewage. No ground water shall be tapped during the operation phase. Metering of the water shall be done and its records shall be maintained.
- 10. Sewage generation during operation phase shall not exceed 84 KLD which shall be treated in the proposed onsite Sewage Treatment Plant.
- 11. The treated wastewater discharge to AMC drainage line shall not exceed 44.7 KLD. Necessary permission from AMC shall be obtained for discharging of same in the drainage line. The treated water to be discharge should meet all standard limits prescribed as per the norms of GPCB/CPCB and competent authority which shall be displayed and inform to local bodies.
- 12. The unit shall install and efficiently operate STP of adequate capacity for treating the sewage to be generated during operation phase to achieve the GPCB norms at the STP outlet. Treated sewage conforming to GPCB norms shall be utilized within premises for gardening & flushing purpose at the maximum extent possible. Only remaining quantity of treated sewage shall be disposed off through drainage line of AMC.
- 13. A proper logbook of STP operation and also showing the quantity of treated sewage utilization within premises & quantity of treated sewage discharged into the drainage line shall be maintained and furnished to the GPCB from time to time.
- 14. Dual plumbing system with separate tanks and lines shall be provided for utilization of treated sewage for flushing.
- 15. No bore well shall be constructed and existing bore well/s, if any, shall be either sealed or converted into the recharge well.
- 16. Rain water harvesting from rooftop and paved areas and ground water recharge through 3 nos. of percolation wells shall be carried out as per the details submitted. Before recharging the runoff, pre-treatment must be done to remove suspended matter.

A.2.2 AIR:

- 17. A D. G. set (125 KVA) proposed as backup power shall be of enclosed type and confirm to prescribe standards under EPA rules. Necessary acoustic enclosures shall be provided at diesel generator set to mitigate the impact of noise.
- 18. The exhaust of the D. G. Set shall be at least 3 m above roof top.
- 19. The gaseous emissions from the D.G. Sets shall conform to the standards prescribed under EPA rules as amended from time to time. At no time, the emission levels shall go beyond the stipulated standards.

A 2.3 SOLID WASTE:

20. The solid waste generated shall be properly collected and segregated at source. The biodegradable waste shall be converted into useful end product by treating it into the proposed onsite Organic Waste Convertor and the recyclable waste shall be sold to vendors whereas the other garbage shall be disposed off properly as per the provisions made by the AMC.

A 2.4 SAFETY AND WELFARE:

- 21. Project Proponent shall obtain fire safety certificate / Fire No-Objection Certificate (NOC) from the concern authority as per the prevailing Rules / Gujarat Fire Prevention and Life Safety Measures Act, 2016.
- 22. Fire fighting facilities like Fire Extinguishers/Fire Hydrant System will be provided. One CO2 type extinguisher of 4.5 kg and one DCP type extinguisher of 5 kg on each floor, hose reels and wet risers will be provided, Basement parking & HPP shall be fully sprinkled system, Fire lifts, Smoke detector, electric fire alarm system, Each floor having a fire alarm call point installed, Separate electric power supply to the entire fire safety system, A lightening arrester will be installed and properly earthed, electric cable duct should have fire rated doors at all level. Under ground Fire water tank not less than of 1,50,000 litre capacity will be provided. Terrace water tank of capacity 20,000 Liters will be provided shall be provided. A lightening arrester will be installed and properly earthed.
- 23. Staircase shall be provided:

- 24. All the staircases shall open out at ground level from the highest point of building [with access from each floor] for emergency evacuation.
- 25. Provision for adequate air changes per hour in the basement shall be made so as to avoid build-up of CO in the
- 26. Car park exhaust system equipped with CO (Carbon Monoxide) sensor shall be provided to ensure operation of exhaust fans as CO concentration levels.
- 27. Clear peripheral margin space of adequate width, in accordance with the concerned local bye-laws, shall be provided for unobstructed & easy movement of vehicles in case of emergency.
- 28. Sanitation facilities, drinking water & tap water, sewage disposal facility, first aid box, free medicines, doctor service, adequate PPEs etc. shall be provided for workers.

A2.5 PARKING / TRAFFIC CONGESTION:

29. Minimum parking space of 5,847.93 m² (768 CPS) [3,807.64 m² in Basement + 2,040.29 m² in Hollow Plinth] shall be provided as proposed.

A 2.6 ENERGY CONSERVATION:

30. Energy conservation measures viz. maximum use of natural lighting through architectural design, energy efficient motors & pumps, water efficient taps, solar lights in open & solar street light, 67 KW solar power generation, use of aerated blocks & RMC, use of LED lighting fixtures and low voltage lighting, roof-top thermal insulation etc. shall be implemented as proposed.

A 2.7 GREEN BELT:

31. Green belt area of 610.52 m² comprising of 252.24 m² tree covered area with 143 trees within premises shall be developed as proposed. The other open spaces inside the plot shall be suitably landscaped and covered with vegetation of indigenous tree species.

B. GENERAL CONDITIONS:

B1. PRE -CONSTRUCTION AND CONSTRUCTION PHASE:

- 32. Mitigation of flood measures shall be undertaken. Height of the plinth and ramps will be increased so that flood water does not enter basement.
- 33. Project proponent shall explore possibilities to reuse the treated waste water for gardening and floor washing.
- 34. Roads leading to or at construction site must be paved and blacktopped (i.e. metallic roads).
- 35. No excavation of soil shall be carried out without adequate dust mitigation measures in place.
- 36. Grinding and cutting of building materials in open area shall be prohibited.
- 37. Construction material and waste should be stored only within earmarked area and road side storage of construction material and waste shall be prohibited.
- 38. Construction and demolition waste processing and disposal site shall be identified and required dust mitigation measures be notified at the site.
- 39. Dust mitigation measure shall be displayed prominently at the construction site for easy public viewing.
- 40. Environment Management Cell shall be formed, which shall supervise and monitor the environment related aspects of the project during construction and operational phases in addition to observance of Gujarat Building and other Construction Workers' (Regulation of Employment & Conditions of Service) Rules 2003.
- 41. Prior permission from the competent authority shall be obtained for cutting of the existing trees before site preparation work is commenced.
- 42. Water demand during construction shall be reduced by use of curing agents, super plasticizers and other best construction practices.
- 43. Wind breaker of appropriate height i.e. 1/3rd of the building height and maximum up to 10 meters shall be provided. Individual building within the project site shall also be provided with barricades.
- Regular water sprinkling shall be done in vulnerable areas for controlling fugitive emission.
- 45. No uncovered vehicles carrying construction material and waste shall be permitted.
- 46. No loose soil or sand or construction & demolition waste or any other construction material that cause dust shall be left uncovered. Uniform piling and proper storage of sand to avoid fugitive emissions shall be ensured.
- 47. Structural design of the project shall strictly adhere to the seismic zone norms for earthquake resistant structures.
- 48. The planning, designs and construction of all buildings shall be such as to ensure safety from fire.

- 49. The project proponent shall ensure maximum employment to the local people.
- 50. All required sanitary and hygienic measures shall be provided before starting the construction activities and to be maintained throughout the construction phase.
- 51. Provision shall be made for housing of construction labor within the site with all necessary infrastructure and facilities such as fuel for cooking, mobile toilets, mobile STP, safe drinking water, medical healthcare, crèches, electricity & ventilation, canteen, rest rooms, safe disposal system for garbage, first aid, medical and emergency facilities etc. to ensure that they do no ruin the existing environmental condition. The housing may be in the form of temporary structures to be removed after completion of the project.
- 52. Adequate personal protective equipments shall be provided to the construction workers to ensure their safety and the project proponent shall ensure its usage by the labours.
- 53. First Aid Box shall be made readily available in adequate quantity at all the times.
- 54. Training shall be given to all workers on construction safety aspects.
- 55. The project proponent shall strictly comply with the Building and other Construction Workers' (Regulation of Employment & Conditions of Service) Act 1996 and Gujarat rules made there under and their subsequent amendments.
- 56. The overall noise level in and around the project area shall be kept well within the prescribed standards by providing noise control measures including acoustic insulation, hoods, silencers, enclosures vibration dampers etc. on all sources of noise generation.
- 57. Ambient noise levels shall conform to residential standards both during day and night. Incremental pollution load on the ambient air and noise quality shall be closely monitored during construction phase
- 58. The noise generating equipments, machinery and vehicles shall not be operated during the night hours and shall be maintained properly to avoid generation of high noise due to wear and tear.
- 59. Use of diesel generator sets during construction phase shall be strictly with acoustic enclosure and shall conform to the EPA Rules for air and noise emission standards.
- 60. Safe disposal of wastewater and municipal solid wastes generated during the construction phase shall be ensured.
- 61. All topsoil excavated during construction activity shall be used in horticultural / landscape development within the project site.

- 68. Fly ash shall be used in construction wherever applicable as per provisions of Fly Ash Notification under the E.P. Act, 1986 and its subsequent amendments from time to time.
- 69. Use of glass shall be minimal and only low emissive glass shall be used in the project to reduce the electricity consumption and load on air conditioning.

B2. OPERATION PHASE AND LIFE TIME:

- 70. Separate Entries and Exits shall be provided to the project on the approach road.
- 71. Separate Entry and Exit to the basement shall be provided.
- 72. Explore possibilities of provision of Electric vehicle charging points in the basement.
- 73. Project Proponent shall provide adequate fund for Environment Monitoring and Staff training in the Environment Management Plan.
- 74. PP shall take all require mitigation measures so as to comply with the ambient noise levels standards of the residential area during day and night time as per Noise Pollution (Control and Regulation) Rules, 2000.
- 75. PP shall take all require dust mitigation measures so as to comply with the National Ambient Air Quality

- standards 2009 and shall provide adequate budget for the same.
- 76. The project proponent shall prepare, display and implement the fire and safety SOPs for fall protection, ladders and stair, scaffolds, trenching and excavation, electrical safety, crane operations, occupational noise mitigation procedure, welding and cutting including provision of PPEs kits etc.
- 77. PP shall ensure allocation of parking to each and every member of the society as per the rules and ensure proper parking and traffic system within the premises to avoid congestion and unsafe parking in the premises. The overall noise level in and around the project area shall be kept well within the prescribed standards by providing noise control measures including acoustic insulation, hoods, silencers, enclosures vibrations dampers etc. on all sources of noise generation including D.G.Sets. The ambient noise levels shall confirm to the standards prescribed under the Environment (Protection) Act and Rules.
- 106. The area earmarked for the parking shall be used for parking only. No other activity shall be permitted in this area.

- 116. Environmental Clearance granted for the project on the basis of documents related to land possession submitted shall become invalid in case the actual land for the project site turns out to be different from the land considered at the time of appraisal of the project and mentioned in the EC.
