- 8. That [1 / the promoter] shall take all the pending approvals on time, from the competent authorities.
- 9. That [1/ the promoter] [have / has] furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
- 10. That [I/ the promoter] shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
