Affidavit cum Declaration of Shri Jimit Sureshbhai Patel, partner/duly authorized by the promoter of firm Signature Realities (Vivaan Ixora), the partners of the proposed project, vide their authorization dated 23th June, 2022;

- I, Shri Jimit Sureshbhai Patel, promoter/duly authorized by all the promoter/partners of the proposed project Signature Realities (Vivaan Ixora), S.P. 128/1, FP No. 128, Draft TPS No. 409/B, Vivaan Ixora, B/H Sangath Prominence, S P Ring Road Zundal, Gandhinagar 382421., do hereby solemnly declare, undertake and state as under:
 - 1. That promoters have a legal title to the land on which the development of the project Signature Realities (Vivaan Ixora) is proposed:

- That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.



- 6. That the amounts from the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
- 7. That promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 8. That promoter shall take all the pending approvals on time, from the competent authorities.
- 9. That promoter has furnished such other documents as have been prescribed by the rules and regulations made under the Act.


