

18 Mtr TP Road to the North FP No. 201/2 to the South F.P.No. 309 to the East 45 Mtr TP Road to the West of Division TPS 2 Ghuma, Survey no.521, 522/A, Final Plot no. 200+201/1, village Ghuma, taluka Daskroi, District Ahmedabad, PIN 380058 admeasuring 4886 sq.mts. area being developed by Golden Projects.

- I, <u>Damjibhai Nathalal Gol</u> duly authorized by the promoter of the proposed project do hereby solemnly declare, undertake and state as under:
 - 1 That promoter has a legal title to the land on which the development of the project is proposed **Swarnim Sun**.
 - That firm has taken Construction Finance of Rs.20,00,00,000/-(Rupees twenty Crore Only) from Bajaj Housing Finance Limited and mortgage was executed in favour of the said Financer, which was duly registered with the Sub-Registrar, S.R.O. Ahmedabad-9 Bopal on 26/04/2023 under Serial No. 6866.
 - That the time period within which the project shall be completed by me/promoter is 31st December, 2026.
 - 4. That seventy per cent of the amounts realized by me/promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
 - That the amounts from the separate account, to cover the cost of the project. shall be withdrawn in proportion to the percentage of completion of the project.


