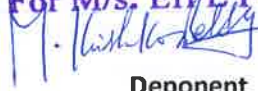

8. That I **M/S.EIPL PROJECTS Rep by M.Kishore Kumar Reddy** shall take all the pending approvals on time, from the competent authorities.

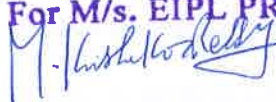

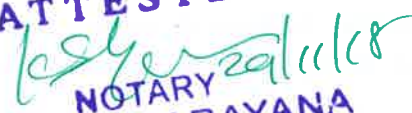
