- That the Registered Undertaking against not misuse of vacant spaces / voids / entrance lobby / part & pocket terrace etc. shall be submitted.
- That the Registered Undertaking agreeing to hand over excess parking spaces to MCGM free of cost in case full permissible FSI is not consumed shall be submitted.
- That the work shall be carried out between 6.00 a.m. to 10.00 p.m. only in accordance with Rule 5A (3) of the Noise Pollution (Regulation & Control) Rules, 2000 and the provision of notification issued by Ministry of Environment & Forest Deptt. from time to time shall be duly observed.

- 10. That the supervision certificate shall be submitted periodically from the Architect / Engineer / Structural Engineer / Supervisor as the case may be as per D.C.Reg. 5(3) (ix) regarding satisfactory construction on site.
- That the safety officer to take care safeties on site during construction shall be appointed.
