Affidavit cum Declaration

1. That Pruthvi Adithya Infratech Pvt. Ltd. has a legal title to the land on which the development of the proposed project (PRUTHVI ADITHYA'S BELMONT GREENE) is to be carried out and a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owners and promoter for development of the real estate project is enclosed herewith.

2. That the said land is free from all encumbrances

8. That Pruthvi Adithya Infratech Pvt. Ltd. shall take all the pending approvals on time, from the competent authorities

9. That Pruthvi Adithya Infratech Pvt. Ltd. has furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.

10. That Pruthvi Adithya Infratech Pvt. Ltd. shall not discriminate against any allottee at the time of allotment of any built up area, as the case may be.
