2.We have estimated the cost of the completion to obtain Occupation Certificate, of the Civil, MEP and Allied works, of the Building (s) of the project. Our estimated cost calculations are based on the Drawings/ plans made available to us for the project under reference by the Developer and Consultants and the Schedule of items and quantity for the entire work as calculated by in-house estimation department employed by promoter, and the assumption of the cost of material, labour and other inputs made by promoter, and the site inspection carried out by us.

- 3. We estimate Total Estimated Cost of completion of the building(s) of the aforesaid project under reference as Rs. 136,02,80,000/-. The estimated Total Cost of project is with reference to the Civil, MEP and allied works required to be completed for the purpose of obtaining occupation certificate/Completion certificate for the building(s) from the PMRDA being the Planning Authority under whose jurisdiction the aforesaid project is being implemented. We estimate Total Estimated Proportionate Cost for completion of Town Level infrastructure as Rs. 6,60,02,720, hence the Total Estimated Cost would be Rs. 142,62,82,720.
- 4. The Estimated Cost Incurred till date is calculated at Rs. 13,56,21,677/-. The amount of Estimated Cost Incurred is calculated on the base of amount of total Estimated Cost.
- 5. The Balance cost of Completion of the Civil, MEP and Allied works of the Building(s) of the subject project to obtain Occupation Certificate from PMRDA (Planning Authority) and Balance Proportionate Cost for completion of Town Level infrastructure is estimated at Rs. 129,06,61,043/-.
- 6. We certify that the Cost of the Civil, MEP and allied work for the aforesaid Project as completed on the date of this certificate is as given in Table A and B below




