- 8. That the Promoter shall take all the pending approvals on time, from the competent authorities.
- 9. That the Promoter has furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
- 10. That the Promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building as the case may be.
