1. - 8. That Brigade Enterprises Limited shall take all the pending approvals on time, from the competent authorities.
- 9. That Brigade Enterprises Limited has furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.

10. That Brigade Enterprises Limited shall not discriminate against any allottee at the time of allotment of any apartment.
