- 1. The Applicant shall pay DC, PC and other charges within 30 days
- 2.
- 3. The applicant shall follow the conditions imposed by HMDA
- 4. The applicant shall not construct the compound wall around the site under reference.
- 5. The applicant shall comply the conditions laid down in the G.O.Ms.No.168, dt.7-4-2012 and G.O. Ms. No. 541 MA
- 6. The HMDA reserve the right to cancel the permission, if it is found that the permission is obtained by false statement or misinterpretation or suppression of any material facts or rule.
- 7. The applicant is the whole responsible if any discrepancy occurs in the ownership documents and ULC aspects and if any litigation occurs, the technically approved building plans may be with-drawn without any notice.
- 8. If any cases are pending in court of law with regard to the site U/R and have adverse orders, the permission granted shall deem to be withdrawn and cancelled.
- 9. The applicant shall provide the STP and septic tank as per standard specification.
- 10. Any conditions laid by the authority are applicable.
- 11. The applicant shall follow the fire service department norms as per act 1999.
- 12. The applicant shall construct all houses in the layout plots as approved by HMDA before release of final layout.
- 13. The applicant shall mortgage for plot no.s 40,41,42,48,49,50,56,57,58,64 & 65,70,71 to an extent of 28,629.00 . Sq. Mt. in Survey No. 428(P),429(P) of Gowdavelly-ORRGC(V) & 26(P),233(P),234(P), 238(P) of Kandlakoya-ORRGC Village, Medchal-ORRGC through registered deed in favour of MC, HMDA and the same shall be submitted to HMDA.

- 15. The applicant shall handover the Layout roads area 6363.52 Sq.mtrs (30.30 %), Open space & utility area 1942.68 Sq.mtrs (9.25 %) Social infrastructure area 554.27 Sq.mtrs (2.64 %)to the Local Body before release of Final Layout plans by HMDA.
- 16. The HMWS and SB and T.S. Transco not to provide the permanent connection till to produce the occupancy certificate from the Sanctioning Authority.
- 17. The submitted architect signature made on the plans and Undertaking on Rs.100 Non Judicial Stamp paper if any discrepancy and misinterpretation, in case in future any objections raised by the concerned architect, the technically approved Layout plans will be withdrawn and cancelled without any notice and action will be taken as per law.
- 18. In large projects where it is proposed to temporarily house the construction workers on the site, proper hygienic temporary shelter with drinking water and sanitary measures shall be provided.
- 19. The Owner/Developers shall be responsible for the safety of construction workers.
