I invite kind attention to the references cited, wherein through the reference cited Smt. Pijaria Shantha Bai & (2) others, have submitted representation for issue of NOC/De-notify for the land bearing Sy. No. 509/3 to an extent of Ac. 01-27 gts., Ac. 01-26 gts., and Ac. 01-27 gts., each as stated below (total Ac. 3-00 gts) situated at Gundlapochampally Village, Medchal Mandal.

Through the reference 2nd cited, RDO, Keestra Division has reported that the matter has been got enquired by the Tahsildar, Medchal and submitted a report stating that, the total facts of the land in Sy.No. 509/3 to an extent Ac.3-00 gts of Gundlapochampally Village, Medchal Mandal are as follows:

- 1) As per the Revenue Records i.e., Khazra pahany for the year 1954-1955 the land in Sy.No. 509 total Extent Ac.772-08 gts classified as "Barani" out of which an extent Ac.3-00 gts was assigned in favour of Sri. K. Venkata ram Reddy S/o K. Marudha Reddy wife Tahsildar Medchal Patta Certificate bearing No. C2/5260/1956, dt. 06-01-1970 and supplementary settlement was issued in respect of land in Sy. No. 505/3 to an extent Ac. 3-00 gts in the name of Sri. Venkat Ram Reddy and the same Patta certificate has been implemented in Patta Patti for the year 1969-1970 as Patta nafa and recorded as Patta dar and ajoyas in the year 1970-1971 but not mentioned in the Records the land was assigned under the capacity of either Political Sufferer or Land Less Poor Person Quota

- 3) Further reported that on verification of the documents produced by the petitioner it is found that a certificate was issued by the Institute of Historical Records of Freedom Struggle dt. 05-09-1993 that certify that Sri. K. Venkatesh Reddy S/o Narayana Reddy R/o Gundlapochampally Village Medchal Taluk, Nalgonda District is a political worker having taken part in the freedom struggle of erstwhile Nizam State during the year 1947-1948. He was also assigned Ac.500 gts of land in Sy.No. 509/3 in Gundlapochampally Village, Medchal Mandal and also an article was written by Sri. K. Venkatesh Reddy S/o Narayana Reddy in the book of "Chakravarthy Charittha Parishadana Samithi, Hyderabad".

4) As per the local enquiry Sri. K. Venkatesh Reddy S/o Narayana Reddy worked as sarpanch above 20 years and he was the first sarpanch of the Gundlapochampally Village.

- 4) Further reported that Sri. Venkat Ram Reddy S/o Narayana Reddy sold the land by a village of Registered Document No. 1457/1980 dt. 21-09-1980 in favour of Pijjerla Jalender Yadav S/o Pijjerla Chitna Somniah and Pijjerla Mallesh Yadav S/o Pijjerla Chitna Somniah in respect of land in Sy.No. 509/3 to an extent Ac.500 gts situated at Gundlapochampally Village, Medchal Mandal.

- 5) On verification of the documents produced by the petitioner Sri Pijjerla Jalender Yadav & Pijjerla Mallesh Yadav S/o Pijjerla Chitna Somniah have made an agreement through an affidavit stating that the subject land was purchased by his brothers namely Sri. Pijjerla Pandu S/o Somniah, P. Krishna S/o Somniah and P. Komarash S/o Somniah and the same has been implemented in Revenue Records and entered in the Entry for the 1993-1996 in favour of Sri. Pijjerla Pandu S/o Somniah to an extent Ac. 127 gts, P. Komarash S/o Somniah to an extent Ac. 127 gts and P. Krishna S/o Somniah to an extent Ac. 126 gts in Sy.No. 509/3 of Gundlapochampally Village, Medchal Mandal.

Further it is reported that following entries are made in Revenue Records in respect of the land in Sy.No. 509 of Gundlapochampally Village are shown below:

Further it is reported that, as per the documents produced by the petitioner and as per local enquiry it is noticed that Sri. K. Venkatesh Reddy S/o Narsa Reddy is Political sufferer. As per the Revenue Records the land to an extent Ac.5-00 g/s was assigned to Sri. K. Venkatesh Reddy S/o Narsa Reddy. Further it is submitted that, Sri. Venkat Ram Reddy S/o Narsa Reddy was sold out the land after holding 30 years of the land. On field verification the subject land is plain and kept badava.

Further it is submitted that the BDO., Narsara Division and Tahsil Coo, Madanol have confirmed that as per local enquiry and on perusal of documents the assignment was made in favour of political sufferer.

Since the assignment made in favour of political sufferer, it is submitted that as per para 2 in G.O. Ms. No. 1743, Dt. 28/08/1955, "the Government have also decided that the political sufferers may be permitted to sell away the lands assigned to them without imposing any condition".

Further a clarification was also issued by the Government of Telangana, vide Memo No. 24362/Asst.1(2)/2017-1, dt. 29/08/2018 on request made by the District Collector Sangli District, wherein it was mentioned that orders issued vide G.O. Ms.No. 307, dt. 06/06/2019 imposing condition of obtaining NOC to sell away the lands assigned to them, relates to ex-servicemen and freedom fighters, not for political sufferers. It is further informed that orders were issued vide G.O. Ms.No. 1745, dt. 14/06/1959 permitting the political sufferers to sell away the lands assigned to them without imposing any condition.

In this connection, the proposals were placed before the D.C. meeting held on 13/05/2019 for perusal, since the NOC is not required in this case (since the assignee is political sufferer) the committee have taken decision to De-notify the land to an extent of Ac. 5-00 g/s. in Sy. Nos. 509/3 (1-27), 505/Ru (1-27) and 505/Ru (1-26) of

Gundapechampally Village, Medchal Mandal, Medchal-Malkajgiri District as stated below
