Subject to the following conditions:

The permission is valid for 6 (Six) Years from the date of issue of permission if the building is constructed or not completed with in the stipulated period the permission will be lapsed.

1. Application for renewal of the permission will be subjected advance i.e., (30) days before the expiry of previous permission failing which the permission will be treated as fresh case.
2. The permission holder should produce the sanctioned plan and the permission for the personal and verification when demanded by the inspectioning authority failed the construction will deemed to unauthorized and action will be taken under provisions of A.P.P.R Act 1994.
