Affidavit cum Declaration

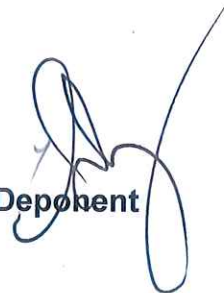
I, Sannareddy Subramanyam Reddy, Managing Director of Aparna Constructions and Estates Private Limited, having Registered Office at 802, Astral Heights, 6-3-352/2&3, Road No.1, Banjara hills, Hyderabad do hereby solemnly declare, undertake and state as under :

1. That the Promoter Aparna Constructions and Estates Private Limited has a legal title to the land on which the development of the proposed project is to be carried out and the legally valid authentication of title of such land is enclosed herewith.
2. That the said land is free from all encumbrances.
3. That the time period within which the project shall be completed by the promoter is 25.08.2028.
4. 6. That the amounts from the separate account shall be withdrawn by the promoter after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
7. That the promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
8. That the Promoter shall take all the pending approvals on time, from the competent authorities.
9. That the Promoter has furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
