ORDER

Chaganla Balvindernath S/o C. Narendranath R/o Flat No. 101, Hill Top Residency, 8-2-310/A/31/A, Nandinagar, Road No. 14, Banjara Hills, Hyderabad has filed an application for grant of Mutation and incorporating their names against Sy.No. 206, extent Ac. 0-18 gts., & 207, extent Ac. 0-28 gts Total admeasuring Ac.1-06 gts., situated at Madeenaguda Village, Serilingampally Mandal of Ranga Reddy District by deleting the existing names of Pattadars to that extent.

Notice has been issued in Form - VIII while giving 30 days time and no objections were received within the stipulated time. The physical status of the land has been got verified by the Mandal Revenue Inspector and Mandal Surveyor and found that the subject land is open land and in possession of the applicant. Hence, the acquisition of right of the applicant by way of Registered Doc.No.2263/2008, dated 27-03-2008 with link document No.1523/AR/2008, dated 05-03-2008 (9-2-1972) is liable to be accepted. Therefore, U/s 4 & 5 of ROR Act 1971 it is hereby ordered to effect the changes by amendment in ROR Register of Madeenaguda Village and necessary changes have to be carried out in the Pahani for the year 2008-09 as under subject to provisions of ULC Act and further claim of Government if any.
