Subject : Issue of 'NOC' for increase in the height of multi-storied building for group housing at Plot No. 95, Loni Road, Ghaziabad by M/s Friends Land Developers Pvt Ltd.

Sir,

I am directed to refer to your letter No. FLD/ATS/06/2009/001 dated 08.06.09 on the above subject and to say that Air HQ has no objection from aviation angle for construction of 40 meters high building at Plot No. 95, Loni Road, Ghaziabad by M/s Friend Land Developers, subject to the following conditions:-

- a) The vertical extent (highest point) of the building shall not exceed 40 meters above ground level/ 254 meters above mean sea level.
- b) Standard obstruction markings and lightings to be provided by the company. The lights shall be switched on during night and poor visibility. Provision shall be made for stand by power supply to the lights to keep them on during power failure.
- c) Periodic maintenance of obstruction markings and lights is to be carried out by the company/ housing society/ tenants at regular intervals to keep them in visible/serviceable condition.
- d) A garbage treatment plant shall be installed prior to the construction of the building for the purpose of avoiding bird activity. The plant shall be shown to the AOC/his nominated representative at AF Stn Hindan on installation.
- e) commencement, completion of works inclusive of obstruction markings and installation of lights shall be intimated to AOC, AF Stn Hindan.
- f) This NOC is valid for three years from the date of issue.

2. You are also requested to obtain No Objection from other concerned Government Organization/Agencies as required.
