Note on Annual Report of RERA Form 5

Note on point no. 3 ii & 3 iii of Form 5

Clause 3 ii – the figure for the amount collected till date is taken right from the inception of the Project. Hence this figure includes the amount collected before enactment of The Real Estate (Regulation & Development) Act, 2016. Hence the same clause includes the amount till date of Annual Report that is 31.3.2018.

Clause 3 iii – Amount withdrawn during the year is taken as per the withdrawal from RERA Account. However amount withdrawn till date is taken as per the amount expended till date of Annual Report that is 31.3.2018. Hence amount withdrawn till date includes amount expended for the Pre RERA period also because of the ongoing project which has been started before RERA enactment. This figure is more even though the amount collected is less for the project.
