III Title Review

On verification of the photocopies of the above documents, it would indicate that Sri.Muniyappa, son of Sri.Nallappa Reddy was the owner in possession of land bearing Survey Number 51- measuring 7 Acres 24 Guntas, having acquired the same vide the Order dated 09/10/1963 in Case No.17/1958-59, passed by the Special Deputy Commissioner for Abolition of Inams.

Sri.Nallappa, Sri.Chennappa and Sri.Thimmappa, sons of Sri.Muniyappa Reddy entered into Deed of Partition dated 27.09.1967, registered as Document No.1873/1967-68, Volume 2633, pages 141-150, Book I, before the office of the Sub-Registrar, Bangalore North Taluk, Bangalore and as per the terms of the Partition portion of the land bearing Survey Number





51- measuring 3 Acres 32 Guntas, situated at Ananthapura Village, Yelahanka Hobli, Bangalore North Taluk, Bangalore, was allotted to the share of Sri.M.Thimmappa, son of Sri.Muniyappa Reddy.

The land bearing Survey Number 51 measuring 7 Acres 24 Guntas, situated at Ananthapura Village, Yelahanka Hobli, Bangalore North Taluk, Bangalore came to be phoded into two Subdivisions ie., Survey Number 51/1 and 51/2 and the land bearing Survey Number 51/2-measuring 3 Acres 32 Guntas, reflects the name of Sri.M.Thimmaiah.

Sri.M.Thimmappa, son of Sri.Muniyappa for self and on behalf of his minor sons Master. Ashok and Master. Anand sold the land bearing Survey Number 51- measuring 3 Acres 32 Guntas, situated at Ananthapura Village, Yelahanka Hobli, Bangalore North Taluk, Bangalore in favour of Sri.M.Nallappa Reddy, son of Sri.Muniyappa vide the Sale Deed dated 24/05/1978, registered as Document No.731/1978-79, Volume 3080, at pages 13-15, Book I, registered before the office of the Sub-Registrar, Bangalore North Taluk, Bangalore.

Mr.T.Ashok and Mr.T.Anand Kumar, sons of Mr. M. Thimmappa, had filed an Original Suit for Partition and other reliefs against their father Mr.M.Thimmappa and others in O.S.No.4663/1987 on the file of the XV Additional City Civil Judge at Bangalore. The said suit came to be decreed vide the Judgment and Decree dated 09.10.2002, as per the terms of the Judgment and decree, Mr. M. Thimmappa and his family members were allotted 1/4th share each in the land bearing Survey Number 51- measuring 3 Acres 32 Guntas, situated at Ananthapura @ Geddalahalli Village, Yelahanka Hobli, Bangalore North Taluk, Bangalore and 1/4th share of Sri. M.Thimmaiah was allotted to Sri. M. Nallappa Reddy.

Aggrieved by the Judgment and Decree passed in O.S.No.4663/1987, Sri.M.Nallappa Reddy, son of Sri.Muniyappa Reddy filed Regular First Appeal No.1277/2002 before the Hon'ble High Court of Karnataka against Mr.T.Ashok, Mr. T.Anand Kumar and others. The said Appeal came to be partly allowed vide the Judgment and Decree dated 24/03/2006. As per the terms of the Judgment it was Ordered that Mr. M. Thimappa, Mr.T.Ashok and Mr.T.Anand Kumar, are each entitled to one-third right, title and interest in the land bearing Survey Number 51-measuring 3 Acres 32 Guntas, situated at Ananthapura @ Geddalahalli Village, Yelahanka Hobli, Bangalore North Taluk, Bangalore and 1/3rd share of Sri.M.Thimappa was allotted to Sri.M.Nallappa Reddy .

Aggrieved by the Judgment and Decree dated 24.03.2006 passed by the Hon'ble High Court of Karnataka in RFA N.1277/2002, a Special Leave Petition (Civil) No.12624/2006 was





preferred by Sri.M.Nallappa Reddy against Mr.T.Ashok and others, which Special leave came to be granted by the Hon'ble Supreme Court of India and the Civil Appeal No.3823/2007 came to be decreed in terms of the Compromise Petition filed by the parties. As per the terms of the Compromise, Eastern half portion of the land Survey Number 51- measuring 1 Acre 36 Guntas (out of 3 Acres 32 Guntas), situated at Ananthapura @ Geddalahalli Village, Yelahanka Hobli, Bangalore North Taluk, Bangalore, was allotted to Mr.T.Ashok and Mr.T.Anand Kumar, and the Western half portion of the land Survey Number 51- measuring 1 Acre 36 Guntas (out of 3 Acres 32 Guntas), situated at Ananthapura @ Geddalahalli Village, Yelahanka Hobli, Bangalore North Taluk, Bangalore, was allotted to Sri. M. Nallappa Reddy.

Pursuant to the order passed in the Civil Appeal No.3823/2007 by the Hon'ble Supreme Court of India, FDP No.98/2002 (O.S.No.4663/1987) in the court of the City Civil Judge at Bangalore, (the share of Sri.T.Ashok and Sri.T.Anand Kumar) came to be registered on 16.08.2008, registered as Document No.YAN-1-01295/2008-09 of Book I, stored in C.D.No.YAND308, in the office of the Senior Sub-registrar Yelahanka confirming the allotment of shares of Sri. M. Nallappa Reddy and another.

Sri.M.Nallappa Reddy and his son Sri.A.N.Gopal Reddy entered into a registered Partition Deed dated 22/01/2009, registered as Document No.YAN-1-02691-2008-09, stored in CD No.YAND 314, Book I, registered before the office of the Sub-Registrar, Yelahanka, Bangalore, as per the terms of the Partition Deed, Sri. M. Nallappa Reddy was allotted Northern portion of property bearing New No.51/2 (Old Survey Number 51), measuring 1 Acre 17 Guntas, situated at Ananthapura @ Geddalahalli Village, Yelahanka Hobli, Bangalore North Taluk, Bangalore and Sri.A.N.Gopal Reddy was allotted the Southern portion of the larger property bearing New No.51/2 (Old Survey Number 51), measuring 19 Guntas, situated at Ananthapura @ Geddalahalli Village, Yelahanka Hobli, Bangalore North Taluk, Bangalore.

The Parties to the above referred Partition Deed dated 22/1/2009 had agreed and undertaken to leave 30 feet road on the Eastern end of land in Survey Number 51/2 measuring 1 Acre 36 Guntas (out of 3 Acres 32 Guntas), situated at Ananthapura @ Geddalahalli Village, Yelahanka Hobli, Bangalore North Taluk running from South to North and another 40 feet road running from south to north passing in the middle of the above said property.

Sri. M. Nallappa Reddy, son of Late Sri. Muniyappa and Sri. A. N. Gopal Reddy entered into Rectification Deed dated 28.07.2012, registered as Document No.YAN-1-02973/2012-13 of Book I, stored in C.D.No.YAND418, in the office of the Senior Sub-Registrar Yelahanka for





deleting 30 feet road on the Eastern end of the Land from south to north in Survey Number-51/2 measuring 1 Acre 36 Guntas, situated at Ananthapura Village.

Owing to an error in the above referred registered Partition deed dated 22/1/2009, the same came to be modified/rectified vide Deed of rectification dated 07.12.2020, registered as Document No.1634/2020-2021, of Book I, stored in C.D.No.MLSD 629, before the office of the Sub-Registrar Malleshwaram (Gandhinagar).

Sri.M.Nallappa Reddy had executed a registered Gift Deed dated 08/05/2009, registered as Document No.YAN-1-00227/2009-10, stored in C D No.YAND 316, Book I, registered before the office of the Sub-Registrar, Yelahanka, Bangalore, in favour of his sons Sri.N.Munirajaiah, Sri.A.N.Krishna Reddy and Sri.A.N.Muni Reddy in respect of Property bearing New No.51/2 (Old Survey Number 51), measuring 1 Acre 17 Guntas, situated at Ananthapura @ Geddalahalli Village, Yelahanka Hobli, Bangalore North Taluk, Bangalore, as per the terms of the Gift Deed, the said land was gifted in the following manner:

- 1. All that piece and parcel Property bearing Survey Number 51/2- measuring 19 Guntas, situated at Ananthapura @ Geddalahalli Village, Yelahanka Hobli, Bangalore North Taluk, Bangalore District, Bangalore was allotted in favour of Sri. Munirajaiah.N.

- 3. All that piece and parcel of Property bearing Survey Number 51/2- measuring 19 Guntas, situated at Ananthapura @ Geddalahalli Village, Yelahanka Hobli, Bangalore North Taluk, Bangalore District, Bangalore was allotted in favour of Sri. A. N. Muni Reddy.

The revenue records in respect of the portion of the land gifted to Sri.A.N.Krishna Reddy, was made out in his name vide the Mutation Register Extract bearing MR No.38/2008-09.

Owing to an error in the above referred registered Gift Deed dated 08/05/2009, the same came to be modified/rectified vide Deed of rectification dated 07.12.2020, registered as Document No.1637/2020-2021, of Book I, stored in C.D.No.MLSD629, before the office of the Sub-Registrar Malleshwaram (Gandhinagar).





The Land in Survey Number-51/2 measuring 3 Acre 32 Guntas, situated at Ananthapura @ Geddalahalli Village, Yelahanka Hobli, Bangalore North Taluk, Bangalore District, Bangalore came to be phoded and assigned sub-numbers in the following manner:

- 1. Portion measuring 2 Acres 15 Guntas in Survey Number -51/2 in the name of Sri. Ashok T. M, Sri. T. Anand Kumar, sons of Sri. Thimappa and Sri. A. N. Gopal Reddy, son of Sri. M. Nallappa Reddy;
- 2. Portion measuring 19 Guntas in Survey Number -51/3 in the name of Sri. A.N. Krishna Reddy;
- 3. Portion measuring 19 Guntas in Survey Number -51/4 in the name of Sri. A.N. Muni Reddy;
- 4. Portion measuring 19 Guntas in Survey Number-51/5 in the name of Sri. N. Munirajaiah;

The Land in Survey Number-51/3 measuring 19 Guntas, situated at Ananthapura @ Geddalahalli Village, Yelahanka Hobli, Bangalore North Taluk, Bangalore District, Bangalore came to be converted vide Official Memorandum bearing No. ALN(NAY)SR:2/2010-11, dated 07.08.2010 from Agricultural Purpose to non-agricultural residential purpose in the name of Sri. A. N. Krishna Reddy.

The property falling within the revenue and administrative limits of the Bruhat Bangalore Mahanagara Palike, Sri.A.N.Krishna Redy, has paid taxes in relation to the same and the property is assigned Bruhat Bangalore Mahanagara Palike Khatha No.276/51/3.

Sri.A.N.Krishna Redy sold Schedule Property in favour of M/s. Allegro Mahabaleshwara Ventures LLP, represented by its Partners Mr. Dharmendra Bansilal Mehta and Mr.Sanjit Naik vide Deed of Absolute sale dated 07.12.2020, registered as document no. 16329/2020-21, stored in C.D.No.MLSD260 of Book I, in the office of the Sub-registrar Malleswaram, Bangalore.

Thus M/s. Allegro Mahabaleshwara Ventures LLP, represented by its Partners Mr. Dharmendra Bansilal Mehta and Mr.Sanjit Naik are the owners of the Schedule Property.

The encumbrance certificates furnished in respect of the Schedule Property would indicate that no registered transactions have taken place in respect of the same since the purchase of the Schedule Property by M/s. Allegro Mahabaleshwara Ventures LLP till the date of this Report.





FINAL OPINION

From a perusal of only the aforementioned documents, I am of the following opinion:

The title to the Schedule Property is clear and M/s. Allegro Mahabaleshwara Ventures LLP have clear and marketable title to the Schedule Property.
