- That M/s. Mokal Brothers Realty Private Limited through its Directors 1) Mr. Nilim Kamalakar Mokal & 2) Mr. Kamlakar Atmaram Mokal has a legal Title Report to the land on which the development of the project is proposed.
- 2. That the project land is subject to following Litigation :
  - a. Special Civil Suit No. 348/2013 filed before Hon'ble Panvel Court.
  - b. Special Civil Suit No. 185/2017 filed before Hon'ble Panvel Court.
- That the time period within which the project shall be completed by M/s. Mokal Brothers Realty Private Limited through its Directors 1) Mr. Nilim Kamalakar Mokal & 2) Mr.Kamlakar Atmaram Mokal, shall be 60 months from the date of registration of project;
